#### Feedback: REaL and SOGI Data Collection

SBAR # 418 REaL and SOGI Data Collection. The Clinical Operations CEC is requesting feedback on proposed changes in TogetherCare to meet CMS compliance. The changes focus on Sexual Orientation and Gender Identity and Race/Ethnicity and Preferred Language. Proposed changes are in red under recommendations of the SBAR.

Trinity Health seeks to advance Health and Racial Equity and consistent data collection is needed to inform our current state so we can understand where disparities exists and design interventions to impact those disparities. Since 1997, the Office of Management and Budget has outlined requirements for federal reporting for all federal funding for collecting race and ethnicity data, with first asking about ethnicity and then asking about race. Additional data standards were published as part of the Affordable Care Act and can be found here: Final Standards - The Office of Minority Health (hhs.gov). The Office of the National Coordinator for Health Information Technology published United States Core Data for Interoperability (USCDIv4) in January 2023, specifically updating and providing more specificity for the collection of patient demographics, including REaL, SOGI and SDOH data. There is a current v4 out for public comment through April 17, 2023. Additionally, CMS, HEDIS and the Joint Commission are beginning to require certain quality and performance metrics be reported by different patient demographics to advance health equity in the United States.

Implementation Bundle: Stewardship of Medical Imaging in Adult Patients Presenting to the Emergency Department with Acute Non-localizing Abdominal Pain

SBAR # 329 Stewardship of Medical Imaging in adult patients presenting to the Emergency Department with acute non-localizing abdominal pain was communicated as a final decision previously. The attached Implementation Guide will assist Emergency Leaders to inform and educate providers of the resource availability within TogetherCare. Implementation of the guidance will assist providers in the diagnosis and treatment of adult patients presenting to the emergency department with non-localizing atraumatic abdominal pain that can reduce unnecessary medical imaging. The algorithm will be made accessible within TogetherCare in the ED Physician Learning Home. A rule will be created that links the nurse driven CC to a banner to notify providers to go to LHD for algorithm. This will not be a hard stop. Implementation is targeted for June 7, 2023, to coincide with TogetherCare updates.

# Feedback: Removing Race Correction from PFT Calculations

The Pulmonary & Critical Care CEC supports removing racial adjustments from Pulmonary Function Testing to provide evidence based and individualized care to those we serve. The PCC CEC recommends that PFT Laboratories adopt a race neutral approach to PFT interpretation by reporting and interpreting results using average reference equations. The Global Lung Function Initiative (GLI) average equation, published as GLI Global, is a recommended race-neutral average reference equation that PFT Laboratories should use.

The CEC is seeking feedback from key stakeholders regarding the recommendations.
